It has been observed that running the CIMPLICITY Object Builder can result in error messages indicating that the path to ProducedData.xml cannot be found or that it doesn't exist.

PPS 3.8 of Zilor - CIMPLICITY/PDS SRTP Proficy Driver Server	US43393	PDS was removed from the PPS installer. PDS can be obtained and licensed by contacting GE Digital. It is not an Emerson product.
